Corona and travels abroad

In connection with travels out of Denmark, we must inform you of The Danish Foreign Offices updated travel guide applicable to January 2, 2021.

What does this mean for us?

At NORDJYSKE Medier/Distribution we follow the Danish Health Authorities guidelines for travels abroad.

As employee you will be told NOT to meet at work the first 14 days after your return. We do this for a precautionary principle and to minimize the risk of infection of Covid 19 amount our employees and to make sure, that we can carry on doing our job at the Distribution?

If you defy the authority's recommendations and become infected during your vacation or is imposed quarantine when you arrive home from abroad, you will have no claim for payment during temporarily lay off or illness, as it is self-inflicted.

We therefore expect you to take 14 days' vacation after returning – the 14 days MUST be agreed with your distribution leader BEFORE your holiday.

As changes can be made according to the different countries' classification, we expect you to keep yourself updated.
